Community Accountability

The Dean of the Student Experience is responsible for all residential community regulations and policies. These regulations and policies are part of the [Housing License Agreement](#) between the university and the resident also referred to as student. Each resident should be familiar with these and other regulations that may be published later.

The purpose of the residential community of the George Washington University is to enhance the academic environment and provide residents with a well-maintained, safe, and positive living experience. Residents have the right to expect an environment that is conducive to study, sleep, and socialization. Residents are responsible for creating an environment that promotes the academic mission of the university and for developing and maintaining an atmosphere that promotes social awareness, social appreciation, and respect of those who may be different from themselves.

Violation of regulations will result in administrative and/or disciplinary action by the university through the Office of the Dean of the Student Experience, or designee, to include but not limited to, the Office of Student Rights & Responsibilities and the Center for Student Engagement. These Residential Community Conduct Guidelines (RCCGs) shall apply to all residential facilities owned or rented by the university through GW Housing. It is expected that individuals living in housing not owned or leased by the university will comply with laws, rules, and regulations applicable to such housing. Failure to comply may, at the discretion of the university, result in disciplinary action. A resident who is accused of being an accessory to a violation is subject to the same charges as the perpetrator of the violation.

Disciplinary action may result in a range of sanctions, including, but not limited to, expulsion, suspension, or termination of the Housing License Agreement for the remainder of the current academic year and/or for an indefinite time period and/or revocation of the privilege to reside in university-owned/rented housing for successive year(s). The university reserves the absolute right to terminate or not renew a Housing License Agreement, or to administratively move a resident at its sole discretion.

Serious violations of regulations may result in the imposition of an interim removal from university housing and/or suspension from the university, pending the outcome of a hearing. Violations of the [“Code of Student Conduct” \(“Code”\)](#) in a residential facility may also lead to suspension or expulsion from the university.

Residential Community Conduct Guidelines

I. Community Standards

1. Conduct Guidelines

All residents are subject to the following conduct guidelines that are particularly applicable to conduct within university residential facilities. A resident or non-resident visitor's conduct at the university should always be governed by respect for the rights of others. The following types of conduct are unacceptable:

A. Depriving Others of Their Rights & Privacy

Residents are free to express themselves in a responsible manner. Such expression is unacceptable when the expression impinges on the rights of others or disrupts administrative or educational activities, approved programs, or events.

1. A roommate who subjects others in the room to systematic stress and/or harassment will be subject to administrative and/or disciplinary action. In cases where it becomes clear that roommates have irreconcilable differences, some or all parties may be subject to an immediate administrative move or disciplinary action.
2. Taking photographs or making audio or video recordings of another person, without their permission, in any context in which that person has a reasonable expectation of privacy is prohibited. For example, residents and non-resident visitors may not photograph or make recordings of other residents or non-resident visitors in any area, including rooms, suites, or restrooms, within the residential facilities without permission. In such areas, permission must be granted by all persons being photographed or recorded.
3. In a situation in which it is not acceptable to take a photograph or make a recording, it is also not acceptable to publish it. Transmission, in print, by phone, via email, via social media, or any other means of technology constitutes publication. Publication of any photograph or recording is also subject to all applicable policies and laws, including copyright, in the same manner as any other image or document.

B. Abuse & Discriminatory Behavior

Abuse, threats, intimidation of others, or language used or action taken on a discriminatory basis, through the use of electronic, written, verbal or physical means, are unacceptable and are subject to administrative and/or disciplinary action. Actions and language that are intimidating, threatening, or hostile to others are unacceptable and are subject to administrative and/or disciplinary action. Abusive or harassing behavior, verbal or physical, that demeans, intimidates, threatens, or injures another person because of their sex, race, national origin, personal characteristics or beliefs include but are not limited to sex, sexual orientation, race, national origin, religion, and disability.

C. Chronic Misbehavior

A resident establishes an unacceptable pattern of misconduct when they frequently violate university policy, although individual offenses may be minor. A pattern of defiance, non-cooperation, irresponsible conduct, or manifest immaturity may be interpreted as a significant disciplinary problem. Residents and non-resident visitors must comply with the directions of university personnel, including residence hall staff, GW police officers and authorized university representatives appointed by the Office of the Dean of Student Affairs and/or the GW Police Department (GWPD). Failure to comply with administrative directions and/or disciplinary sanctions imposed by those with proper authority is unacceptable conduct and will result in severe disciplinary consequences. **Generally, the third violation of any policy may result in a referral for termination of the Housing License Agreement.**

D. Misuse of Staff Resources

A resident, or their proxy, who occupies an inordinate amount of staff time and energy reflecting their dissatisfaction with residential living, and/or who exhibit behaviors that signify the inability to live in a residential community may be required to meet with an Office of the Dean of the Student Experience staff member to discuss whether the resident should be moved to another residential facility, continue in residence, and/or whether the Housing License Agreement should be renewed for a future academic year. The university reserves the right to terminate or not renew a Housing License Agreement, or to administratively move a resident at its sole discretion.

2. Noise & Quiet Hours

All residents will be considerate of others within their community in regards to noise level. All residents have the right to study and sleep without undue interference. Noise that interferes, or has the potential to interfere, with those rights is considered a violation. All residents are expected to help maintain an atmosphere suitable for study or sleep. Residents should respond to requests from other residents or university personnel to lower the noise level of their activity, and to adhere to residential facility quiet hour rules. Quiet Hours will be in effect in all residence halls during the following hours: Sunday-Thursday: 10pm-7am; Friday-Saturday: 2am-10am. Excessive noise may be defined as, but is not limited to, the following: blaring sound systems, banging on doors or walls, shouting out of windows or down hallways, music, and shouting or talking that is audible beyond the confines of the room. Failure to respond to requests to lower the noise or music level may result in administrative and/or disciplinary action.

During reading days and final exams, quiet hours will be in effect 24 hours per day, unless otherwise expressly authorized by GW Housing or the Center for Student Engagement. **In general, a resident's right to quiet supersedes any other resident's right to make noise.**

3. The Playing of Sports

The playing of sports of any kind in the hallways and/or other common areas of the residential facilities is prohibited. This includes, but is not limited to: water fights, biking, in-line skating, skateboarding, or "hall ball" of any kind. The university reserves the right to bill the resident(s) responsible for damage caused by playing sports in the residence halls.

4. Animals

Animals are not permitted in residential facilities, even when for a brief visit or when brought in by a non-resident visitor, except for properly attended service or assistance animals for individuals with disabilities (assistance animals must be registered through [Disability Support Services](#)) or as required by applicable laws and approved live-in professional staff pets. Residents who, because of a disability, seek approval for an assistance animal must request reasonable accommodations through the Office of Disability Support Services and must provide supporting documentation. **Residents may not bring an assistance animal into the residential facilities until after receiving written approval from Disability Support Services and GW Housing. Approval may be revoked and other action may be taken, as appropriate, for failure to follow guidelines and university policies regarding animals on campus.** Refer to the [Assistance Animal Guidelines](#) for further information on this policy.

In the event animals, including laboratory specimens or visiting pets, are found in a residential facility, the university reserves the right to have them removed and to bill the resident(s) responsible for necessary extermination, cleaning services, or other costs associated with removal of the animal and/or repair of residential facilities. Administrative and/or disciplinary action may also be taken.

5. Smoking Policy

Smoking is prohibited in or around all university owned and managed residential facilities, including residence halls and townhouses. Residents may not smoke or inhale tobacco or other smoking products, by any method, including, but not limited to, cigarettes, cigars, pipes, e-cigarettes, and hookahs inside a residential facility or within twenty-five feet from any GW residential facility including within courtyards and on balconies.

It is a policy of the university to promote a smoke-free environment at each of its campuses, including in all university owned and managed buildings, university owned and leased vehicles, and on university owned outdoor spaces as well as on public space that abuts buildings in the Foggy Bottom campus. Further information on the university's smoke-free policy can be found at the Smoke-Free GW web site at: smokefree.gwu.edu.

II. Alcohol and Drugs

1. Alcohol

Only individuals who are 21 years of age and older may possess and consume alcoholic beverages in residential facilities and rental properties owned or controlled by the university. Individuals who are 21 years of age and older may not consume alcoholic beverages to the point of intoxication or otherwise endanger their own safety or the safety of others.

Individuals who are 21 years of age and older may only possess and consume alcoholic beverages within the confines of their room and the rooms of other individuals who are 21 years of age and older.

If an individual is at least 21 years of age, and resides with another individual who is younger than 21 years of age, only the individual who is at least 21 years of age may possess and consume alcoholic beverages within the shared room or suite. Individuals 21 years of age and older may not provide any alcoholic beverages to individuals younger than 21 years of age.

No individual younger than 21 years of age is permitted to possess or consume alcoholic beverages within any area of a residential facility owned or controlled by the university. When all residents of a room are younger than 21 years of age, the possession and consumption of alcoholic beverages in that room is strictly prohibited.

Individuals who violate this policy are subject to arrest and/or disciplinary action under the [Code of Student Conduct](#).

In addition to the restrictions and obligations imposed by law regarding the possession or use of alcoholic beverages, an individual's right to reside in an alcohol free environment supersedes another individual's choice to violate the law and/or the university's alcohol policies.

Staff will confiscate or dispose of alcoholic beverages in the possession of individuals younger than 21 years of age. If alcoholic beverages are confiscated from a room and no resident or non-resident visitor accepts responsibility for the alcoholic beverages, all residents and/or non-resident visitors of the room may be held accountable and subject to disciplinary action. The university may deem alcoholic beverages found in any area of a resident's room or suite to be in the resident's "possession." No resident or non-resident visitor may provide alcoholic beverages to any individual younger than 21 years of age; and no resident may allow any individual younger than 21 years of age to consume alcoholic beverages in the resident's room. Violators are subject to disciplinary action and may also be referred to local law enforcement authorities for prosecution.

- A. The possession, sale, service and consumption of alcoholic beverages in a residential facility owned or controlled by the university is subject to the Alcoholic Beverage Consumption and Distribution Policy.
- B. Student groups and organizations holding events in a residential facility owned or controlled by the university shall comply with GW's [Alcoholic Beverage Consumption and Distribution Policy](#). Clubs, groups, and organizations must also abide by any policies imposed by the groups or organizations with which they are affiliated, provided these policies are not inconsistent with university policy.

- C. Individuals who are 21 years of age and older may possess or consume alcoholic beverages at registered and approved events within residential facilities owned or controlled by the university, in accordance with the Alcoholic Beverage Consumption and Distribution Policy.
- D. Kegs and other bulk or common source containers, as well as large quantities of alcohol are prohibited. Individuals in possession of kegs, other bulk or common source containers, or large quantities of alcohol may be subject to disciplinary action with possible outcomes to include, but not limited to, the termination of the resident's Housing License Agreement.
- E. Alcoholic beverages must be in closed and concealed containers when transported to, from, and within any residential facility owned or controlled by the university.
- F. Drinking games or contests of any kind are prohibited. Residents who participate in or allow drinking games or contests to occur within any area of their assigned residence, including a resident's room, suite, or other common areas of the residential facility are subject to disciplinary action.
- G. No resident or non-resident visitor may manufacture or distill alcoholic beverages within any residential facility.

2. Drugs

Possession, use, distribution, manufacture, or sale of illegal drugs and controlled substances is prohibited. The possession of paraphernalia associated with the use of illegal drugs or controlled substances is also prohibited. The misuse or unauthorized possession of controlled substances, including but not limited to, prescription medications, by a resident or non-resident visitor is also prohibited. The university may deem any prohibited substance or paraphernalia found in any area of a resident's room or suite to be in the resident's "possession." Distribution includes any form of sale, exchange or transfer of illegal drugs or controlled substances, including but not limited to, prescription medications.

Authorized university staff will confiscate illegal drugs and controlled substances, unless individuals in possession are legally authorized to possess the substances, such as prescription medication. Staff will also confiscate paraphernalia associated with the use of drugs or controlled substances and transfer custody of such items to GWPD or another appropriate police agency, such as the Metropolitan Police Department (MPD). If prohibited substances or paraphernalia are confiscated from a room or suite and no resident, or non-resident visitor accepts responsibility for the item(s), all residents and/or non-resident visitors of the room may be held accountable and are subject to disciplinary action. Violators are subject to disciplinary action and may be referred to local law enforcement agencies for prosecution.

III. Health, Safety, and Security

1. Identification

All residents and non-resident visitors must present proper identification on request of any residence facility staff or authorized university personnel. Failure to do so, or presentation of altered, fraudulent, false, or otherwise illegal identification, will result in disciplinary action taken by the university. Please note that it is a violation for a student to lend their GWorld card to anyone else, including non-resident visitors and/or family members. It is also prohibited for a student to allow another person the use of their GWorld card to gain access into a residential facility. A student found possessing or using another person's GWorld card will be subject to disciplinary action.

2. Visitors

Residents will be held responsible for the behavior of their non-resident visitors and for their non-resident visitors' adherence to residential facility and university regulations. Visitation within student rooms is determined by mutual agreement among roommates at the beginning of the year and revisited whenever occupancy of the room changes. Overnight non-resident visitors are allowed for no more than eight (8) nights per month and for no more than four (4) consecutive nights. A primary obligation of GW Housing and the Center for Student Engagement is to attempt to ensure adequate study and sleep conditions for residents. These priorities take precedence over residents' social activities.

Cohabitation is not allowed in the residence halls. Cohabitation is defined as a person using a residence hall room as if that person were living in the room but not actually being assigned as a resident of that room/suite.

Two important overall considerations govern in permitting visitors in halls and rooms. One is the need to provide for the rights of roommates, suitemates, and neighbors to not have visitors, and the other is the need to protect residents from access to the halls and rooms by unauthorized individuals.

Residents may not admit into residential facilities individuals who are not known to them or who are not their own personal visitors. Residents must escort their non-resident visitors at all times within any residential facility. Authorized representatives, including, but not limited to, GW Housing or GWPD staff, are instructed to prevent admittance of unauthorized individuals when they observe it. Residents should submit the Overnight Stay Request Form, available at GW Housing e-Services, to register any overnight visitors. Cooperation with this policy is essential to the safety of persons and property.

Conflicts or problems regarding visitation and infractions of visitation policies or procedures will be subject to administrative and/or disciplinary action, as appropriate.

3. Safety Hazards

Residents should maintain a constant vigilance against the possibility of fire or other hazardous conditions in the residential facilities. The GW Office of Safety and Security will conduct periodic health and safety inspections to monitor compliance with university policy on safety hazards.

Residents and non-resident visitors are prohibited from possessing or using items which have been identified by the university as being hazardous to the residential community. **Prohibited items as determined by the Office of Safety & Security include, but are not limited to, the following:** candles, incense, lanterns, oil lamps, flammable liquids for cleaning, burners for heating or any other purpose (ex. objects with open flames), halogen lamps of any shape or style, and any other potentially dangerous materials. Use of heat-producing appliances for food preparation in resident's licensed space or in any other area not specifically designated for this purpose is prohibited. Hanging sheets or similar combustible materials is also prohibited.

Any "prohibited item" found to be in a resident's or non-resident visitor's possession will be immediately disabled, confiscated and/or disposed of without compensation. Violations of this policy are subject to administrative and/or disciplinary action, as appropriate.

Information related to health and safety inspections or an administrative search of a licensed residential space can be found in the **Housing License Agreement**. A detailed list of prohibited items is available on the Office of Safety & Security website at: <https://healthandsafety.gwu.edu/prohibited-items-residence-halls>.

Residential facilities and university owned or operated buildings and office areas are to be entered only during scheduled hours. It is prohibited for a person to enter any area where access is limited to only authorized personnel (e.g. attics, roofs, tunnels, equipment and storage rooms, private housekeeping closets, private office areas, unoccupied rooms, unoccupied university-owned apartments, loading or service areas, etc.), except where permission has been expressly granted in each instance.

Alarms and emergency stop buttons located in elevators are to be used only in cases that dictate an emergency. Elevator maximum capacity limits are to be followed. Jumping, shaking and related activity is prohibited in elevators.

The university strongly discourages possession and use of fire ladders. All residents are advised that the university will bear no responsibility for the use of these ladders under any circumstances and that non-emergency use of such ladders will result in disciplinary action.

4. Fire and Safety

Fire safety equipment in the halls includes, but is not limited to, fire extinguishers, smoke detectors, EXIT signs, fire extinguisher cases, fire panels, and all components of the sprinkler and other fire or life safety equipment systems. Accessing and tampering with fire or life safety equipment without the authorization of a university official is an offense against the residential community and the university. Residents who engage in activities listed in this section will be responsible for the cost of restoring the equipment to its normal operation and for the cost of any damage to the building and its contents, whether owned by the university or by the other occupants of the building. Residents are subject to administrative and/or disciplinary action, may be fined, have their Housing License Agreement terminated, and may also be charged and prosecuted for these offenses under the laws of the District of Columbia.

- A. Regardless of whether or not fire systems and equipment responds, residents should not knowingly or negligently cause or attempt to cause a false alarm by setting off a fire alarm system or give any other common or recognized alarm of fire or bomb threat. Such action endangers the lives of others and may cause damage to the persons and/or equipment responding to such false alarms.

Activating the emergency alarm in an elevator when no emergency exists is considered tampering with safety equipment, as well as a violation of the noise regulation, and will result in disciplinary action.

- B. Tampering with, abusing, misusing, accessing without authorization, or in any way reducing or eliminating the efficiency of smoke or fire detectors or fire safety panels located in hallways, common areas, or in rooms, and misuse or tampering with or purposefully or accidentally damaging fire extinguishers, sprinkler systems, security cameras, or any other fire or life safety equipment is prohibited. **Touching or hanging objects from sprinkler heads or other fire safety equipment is prohibited. Residents may be held financially responsible for damages caused by tampering with, abuse, or misuse of fire safety equipment.**
- C. Regardless of whether or not fire systems and equipment responds, residents shall not make and/or communicate to another, by any means, any threat to bomb, burn, destroy or in any manner damage any place of assembly, building or other structure or any means of transportation. Residents will not communicate to another by any means, knowing the information to be false, the existence of any peril of bombing, burning, destruction or damage to any such place of assembly, building or other structure, or any means of transportation.
- D. Residents shall not knowingly or negligently cause or attempt to cause a fire in a university building. Such action endangers the lives of others and may cause property damage or loss. Residents must adequately monitor items being heated in ovens and on stovetops. Residents or non-resident visitors may also be charged and prosecuted for these offenses under the laws of the District of Columbia.

5. Fire Drills

Immediately upon moving into or visiting a residential facility, every resident and non-resident visitor should become familiar with fire exit routes and locations of fire extinguishers. Detailed instructions and procedures to be followed in case of fire and/or fire drills are posted in every room. When a fire alarm sounds, all persons must immediately evacuate the building, exiting by the most direct safe route. Occupants must evacuate the building to an area far enough away to ensure their personal safety. All residents and non-resident visitors must report to their designated evacuation points. All occupants must evacuate in a timely manner. Disciplinary action may be taken in cases of failure to evacuate in a timely manner.

6. Endangering Behavior

Behavior of any kind that risks or jeopardizes the health or safety of any person or persons is prohibited.

7. Windows, Balconies, Rooftop Decks and Pools

Window screens are to be left in place and closed at all times. Tampering with restrictors on screens, windows, or doors is strictly prohibited. Doors to balconies that the university has prohibited access to may not be tampered with by any individual to permit access. Individuals are prohibited from accessing the roofs of university residential facilities, unless otherwise posted or authorized in writing by proper university authorities. Swimming pool use is limited to designated time period(s) between Memorial Day and Labor Day, when a lifeguard is present. Unauthorized use of or access to the swimming pool, deck, or patio area is strictly prohibited. The university may, at its sole discretion, limit or prohibit the use of balconies and rooftop decks at any time.

Intentional or unintentional throwing, dropping, allowing to fall, lowering of, or in any way putting any object, solid or liquid, out of a window, from a balcony, or rooftop deck of a residential facility is strictly prohibited. If the offender cannot be determined, charges may be assessed and equally billed to all residents of the residential facility where the damage occurred. Violations will be subject to administrative or disciplinary action. When such acts seriously threaten or injure the life, safety, or property of others, a violator may be subject to disciplinary action with possible outcomes including, but not limited to, the termination of a resident's Housing License Agreement, suspension, or expulsion.

8. Trespass

No person may enter, attempt to enter, or remain in any residential facility owned or managed by the university, including, without limitation, any room, area, or part thereof, without an effective license or authorization. All non-resident visitors of licensed residents must adhere to university policies relating to visitation by non-residents, and must vacate the residential

facility upon request of the university or the individuals they are visiting. Any person who violates this policy may be subject to arrest and/or disciplinary action under the Code of Student Conduct.

9. Excessively Aggressive Recruitment Tactics

All students, non-resident visitors, groups, campus organizations, nationally-affiliated organizations, or religiously-affiliated groups must follow university policies and procedures regarding the recruitment of individuals who reside in the residential facilities. Recruitment of residents as potential new members of any group or organization shall not be conducted in an excessively aggressive manner. In the event recruitment activities are directed toward a resident, after the resident has indicated that they do not wish to join the group or organization, the activities will be considered excessively aggressive. Continued visits, phone calls, electronic communications, and/or unreasonable pressure to join any group or organization are behaviors included within, but not limited to, the scope of this section.

IV. Solicitation & Postering

1. Solicitation

The use of resident rooms, suites, apartments, and townhouses are limited to residential housing use. Residential facilities are not to be used for any business or commercial use or by any social organization, groups, including but not limited to Greek social organizations, associations, clubs, or other student organizations, etc. Exceptions to this policy may be made at the university's discretion.

Soliciting and selling in residential facilities owned/managed by GW Housing is strictly forbidden.

Residents are not allowed to conduct private businesses or to use residential facility amenities for this purpose. Residents engaged in such activities will be subject to disciplinary action. This includes conducting business from an online service provided by the university over the Internet from a residential facility. All individuals must follow the Acceptable Use Policy for Computing Systems and Services. Both documents can be found on the Division of IT Helpdesk web site at: <http://helpdesk.gwu.edu>. Fund-raising activities by any individuals, student groups, or organizations may be authorized within specific guidelines approved by the Dean of Student Affairs or designee, and enforced by GW Housing staff.

2. Postering & Dorm Storming

All residents, non-resident visitors, groups, campus organizations, nationally-affiliated organizations, or religiously-affiliated groups must follow university policies and procedures regarding the recruitment of individuals within residential facilities.

Postering and the distribution of palm cards or other print marketing material is subject to specific guidelines and only approved materials may be posted or distributed. Posters and palm cards may be posted on residential facility bulletin boards only; poster and palm cards may not be placed on any painted wall surface or placed under doors.

Students are prohibited from causing damage to, destruction of, or drawing graffiti on bulletin boards and their contents.

Copies of postering and dorm storming guidelines are available on the GW Housing website at <http://living.gwu.edu/posters-promotions>. Posters and palm cards must be approved by GW Housing, located in Philip Amsterdam Hall at 2350 H Street, NW, Suite 106. Residents, students, groups, and/or student organizations found postering, dorm storming, distributing, or littering unapproved fliers, posters or palm cards in the residential facilities may be charged through the disciplinary process.

ALLEGED VIOLATIONS OF REGULATIONS CONTAINED IN THIS DOCUMENT WILL BE RESOLVED IN ACCORDANCE WITH THE "CODE OF STUDENT CONDUCT" OR BY GW HOUSING, AS APPROPRIATE.
